

Warning of Election

November 5, 2024, State Election

The Electors of the Town of Waterbury are hereby warned to meet at their respective polling places in said town on Tuesday, November 5, 2024, for the following purposes:

- I. To cast their votes for Presidential and Vice-Presidential electors, United States Senator, Representative in Congress, State Senator, State Representative, and Registrar of Voters,
- II. To vote on the following question for the approval or disapproval of a proposed Amendment to the Constitution of Connecticut, a vote of “Yes” being a vote for approval, and a vote of “No” being a vote for disapproval:

1. Shall the Constitution of the State be amended to permit the General Assembly to allow each voter to vote by absentee ballot?

The vote on the proposed question is taken pursuant to the Constitution of Connecticut. The full text of such proposed question with explanatory text, printed in accordance with Sec. §2-30a of the General Statutes, is available at the Town Clerk’s Office for public distribution.

- III. To vote on the following local questions for the approval or disapproval of proposed Amendmenst to the Charter of the City of Waterbury, a vote of “Yes” being a vote for approval, and a vote of “No” being a vote for disapproval:
 - 2 Shall the Charter be revised in accordance with the recommendations of the Charter Revision Commission, as approved by the Board of Aldermen, as published, posted on the website of the City and further described in an explanatory text issued by the Town Clerk?
 - 3 Shall the Charter be revised to eliminate the current requirement of five year residence in the City in order for a person to be eligible to run for Mayor, in accordance with a judicial determination overturning such a provision in another Connecticut municipality?

The vote on the proposed questions are taken pursuant to Sec. 3A1 of the Charter of the City of Waterbury and Sec. §7-191 (e) and (f) of the General Statutes. The full text of such proposed questions with explanatory text, printed in accordance with Sec. 9-369b of the General Statutes is available at the Town Clerk’s Office for public distribution.
