- 1. <u>Veterans</u> Veteran's points will be awarded in accordance with the Connecticut State Statute. Five (5) for non-disabled veterans, ten (10) for disabled veterans. Proper documentation must be submitted to the Personnel Director before the date of the examination.
- <u>Residents</u> Five (5) Residency points shall be added in accordance with the amendment to the Civil Service Ordinances dated March 18, 2011. Proper documentation and proof of residence must be submitted no later than the closing date for applications.

Repairs pipes and valve traps in the heating systems.

Cuts, bends and threads pipes.

Assists skilled workmen of related trades in general plumbing maintenance work.

Maintains plumbing tools and equipment.

May repair swimming pool piping and filters.

Does other related work as required.

Possession of a **valid P-1 license issued by the State of Connecticut**. Incumbents in this class are required to possess a current Motor Vehicle Class D Operator License and have a good driving record

COPIES OF <u>HIGH SCHOOL DIPLOMA, TRANSCRIPTS OR GED AND DRIVING RECORD</u> MUST BE SUBMITTED AT TIME OF APPLICATION

In order to verify possession of the appropriate Driver's License and good driving history, applicants will now be required to provide the H.R. Office with a Driving History Report that is less than 30 days old. Only reports generated by the <u>Department of Motor</u> <u>Vehicle</u> will be accepted. <u>This information will be specifically requested of the applicants at the time that a conditional offer is made</u>. In the event that a report is not supplied within (7) seven days or the H.R. Director deems your driving history to be poor, the conditional offer may be rescinded.
