**IMPORTANT:**

**Veterans** – Veteran's points will be awarded in accordance with the Connecticut State Statute. Five (5) for non-disabled veterans, ten (10) for disabled veterans. Proper documentation must be submitted to the Personnel Director before the date of the examination.

**Residents** – Ten (10) Residency points shall be added in accordance with the amendment to the Civil Service Ordinances for Maintainer I position dated August 21, 2017. Proper documentation and proof of residence must be submitted no later than the closing date for applications.

**EXAMPLES OF WORK:** (Illustrative only) **ALL AREAS:**

Work involves responsibility for performing a variety of annual and mechanical tasks. Performs work under general supervision. Keeps simple records and prepares reports; performs related duties as required.

**BUILDING MAINTENANCE / SECURITY:**

Routine cleaning; General maintenance and repair of buildings; Minor repairs and maintenance of equipment; Delivers packages and messages; Building security and safety; Empties refuse cans, collects paper and rubbish; Shovels snow, mows lawns and performs other ground maintenance tasks.

**GROUNDS MAINTENANCE:**

Performs routine manual work in the maintenance and development of parks; General maintenance and repair of buildings and playgrounds; Minor repairs and maintenance of equipment; Operates small motorized and hand grass mowers.

**MANUAL LABOR:**

Routine heavy manual work, lifting, loading and unloading; Maintains sewers and manholes; Loads and unloads equipment and supplies; May assist other skilled workers in areas such as plumbing, carpentry etc.

**TRADES HELPER:**

Assists in the repair of cabinets, desks, tables and other office furniture; Builds forms and performs other rough carpentry jobs; Carries lumber and other materials and supplies as directed; Performs trades tasks of the journeyman level on occasion; Files, sands, sharpens other tools and keeps equipment in proper working order

**REQUIRED KNOWLEDGE, SKILLS AND ABILITIES:** Ability to understand and follow simple instruction, some interpersonal skills, written and oral, ability to maintain simple record keeping, ability to learn policies and procedures, must be reliable; must be able to lift heavy objects and able to work in adverse weather conditions.
