1. ELECTION OF *Temporary President* OF THE BOARD OF ALDERMEN.

On a motion of Alderman Joseph Begnal, Jr., duly seconded by Alderman Anthony Piccochi, the Board of Aldermen voted unanimously to ***Elect Ryan A. Mulcahy as Temporary President.***

2. ELECTION OF *Permanent President* OF THE BOARD OF ALDERMEN.

On a motion of Alderman Anthony Piccochi, duly seconded by Alderman Ronald A. Napoli, Jr., the Board of Aldermen voted by unanimous roll call vote to ***Elect Paul K. Pernerewski, Jr. as Permanent President.***

3. ELECTION OF *President Pro-Temp* OF THE BOARD OF ALDERMEN.

On a motion of Alderman Joseph Begnal, Jr., duly seconded by Alderman Gregory Hadley, the Board of Aldermen voted by unanimous roll call vote to ***Elect Ronald A. Napoli, Jr. as President Pro-Temp.***
